- 1. Only the pet listed and described below is authorized under this pet agreement. Application for additional or other pets must be made to and approved by the owner/management prior to owning the pet/moving the pet into the unit.
- 2. Tenant agrees to accept full responsibility and liability for any damage, injury, or actions arising from or caused by his/her pet.
- 3. Tenant is encouraged to purchase and keep in effect Renter's Insurance (which carries liability coverage) on all dogs. Proof of insurance, if any, should be provided to the office for inclusion in your tenant file.
- 4. Tenant agrees to register the pet in accordance with local laws and requirements. Tenant agrees to immunize the pet in accordance with local laws and requirements.
- Tenant agrees to promptly clean up after the pet. Pet will not cause danger, damage, nuisance, noise, health hazard, or soil the apartment, premises, grounds, common areas, walks, parking areas, landscaping, or gardens.
- 6. Pet shall not be left outside unattended.
- 7. Tenant warrants that the pet is housebroken. Tenant also warrants that the pet has not had a history of causing physical harm to persons or property, such as biting, scratching, chewing, etc, and further warrants that the pet has no vicious history or tendencies.
- 8. Tenant agrees to observe the following regulations:
